

The author of the Devon123.org domain was also the author of the Federal complaint filed against Major Clinton Francis Greenwood of the Harris County (TX) Sheriff's Office. Eight weeks after this Federal complaint was filed Greenwood - using the police and prosecutorial powers of the District Attorney's Office - arrested the plaintiff, the author, and the process server of this Federal complaint. In the past 32-months the peace officers involved in the Federal complaint against Greenwood were forced to appear in criminal court more than 110 times.

On Sunday-September 2, 2014 (Labor Day weekend) Allen Blakemore visited the domain Devon123.org. Blakemore was the political campaign manager for Devon Diane Anderson.

This visit was identified by his IP address 66.60.229.124 ("pixblakemore.phonoscope.com" / ASN 22442). The next day repeated visits by the Anderson administration were made from the IP address 38.100.76.235 which was owned by the Harris County (TX) District Attorney's Office.

Allen Blakemore revisited the Devon123.org domain regularly, to include a visit at about 1:00 PM Central Standard Time on Tuesday-July 7, 2015 from his IP address 66.60.229.124.

The court staff contacted Baumgart directly (not his attorneys) and ordered him to appear in court. Baumgart was not given notice for the reason of this hearing and the court staff claimed that they did not know the reason for the hearing.

At the time, Baumgart had four attorneys and none of them had been given notice of this secret hearing. The clerk's entry simply reads "TO SEE JUDGE" as the reason for the hearing.

At the hearing, Junior Assistant District Attorney Thomas Heyward Carter III asked the Court to jail Baumgart indefinitely because Baumgart published the Devon123.org domain; but, Carter told the judge that he "had no dog in this hunt" which meant that Carter was under orders of the Anderson administration. Carter was a punk for Anderson.

The clerk's entry indicates that no attorney was present when in fact at the time Baumgart was represented by four different attorneys, two of which were present for this secret hearing.

Eric Lynn Baumgart was a Master Texas peace officer who was involved with criminal and civil complaints charging senior members of the Harris County (TX) District Attorney's Office with corruption. In retaliation the District Attorney's Office arrested everyone involved in the Federal complaint - the plaintiff, the author, and the process server.

In a 32-month period Baumgart (the author of the Federal complaint) had been repeatedly charged by the Anderson administration. In this time Baumgart received 14 dismissals and 1 acquittal only to be re-filed on by the Anderson administration. In open court the Anderson administration vowed to keep arresting Baumgart until he was found guilty for something.
